ORDER

As per GO read as 2 nd paper above permission was granted to the DDOs of all Govt Departments, including Aided institutions only to e submit the digitally signed SPARK Bills for the salary claim of 03/2020 without submission of any signed hard copy of the outer/inner /schedules of the same to Treasuries subject to certain conditions and vide GO read as 3 rd paper above extension was granted for salary claims of 4/2020 also. Now requests are being received to grant exemption of hard copy submission of bills and proceedings for temporary employee's remuneration also, considering the COVID - 19 issue.

Government have examined the matter in detail and are pleased to accord sanction to give exemption to hard copy submission of bills and proceedings / orders for claiming the remuneration of temporary employees with TEN in SPARK for the months 3/2020 & 4/2020, in the case of all Government Departments including aided institutions, considering lock down situation due to COVID - 19 issue, subject to the condition that the bills are to be e-submitted with digital signature and scanned copy of the proceedings/orders sanctioning the monthly remuneration of these temporary employees are submitted via e-mail to Treasuries concerned with subject "Bill for temporary employees-Institution's name and DDO code".

It is also ordered that the duly authenticated hard copy of the bills and proceedings/orders are to be submitted to treasuries concerned as and when the lock down period is withdrawn and physical copy submission is possible.
