Sub : COVID 19 –Covid 19 Outbreak Control – Relaxation of the Coastal Critical Containment Zone in the Coastal region of Thiruvananthapuram district – Orders issued.

Whereas, Covid-19, is declared as a global pandemic by the World Health Organization. Government of India also declared it as a disaster and announced several measures to mitigate the epidemic. Government of Kerala, has deployed several stringent measures to control the spread of the epidemic.

And whereas, SRO notification issued by Govt of Kerala as Kerala Epidemics Diseases, Covid 19, Regulations 2020 in official gazette stipulates that all possible measures shall be incorporated to contain the disease.

And whereas, the containment activities in the Coastal Containment Zone were intensively carried out and as result the further surge of the disease spread to other parts of the district was contained to a large extent, however the incidence rate of disease did not show considerable reduction.

And whereas, there is a genuine need to relax the strict restrictions so as to resume usual social and economic activity but with certain restrictions so as to sustain the containment measures regarding the spread of the disease.

And whereas, the district authority has examined the need for giving more relaxation in the coastal area which are genuine and be permitted.

And now therefore, I, Dr. Navjot Khosa IAS, District Collector & Chairperson of District Disaster Management Authority under the powers vested with me as the District Authority to invoke the provisions envisaged in the sec 26, 30 and 34 of the Disaster Management Act 2005 and passes the order as follows.

Order

1. The Critical Containment Zone in the Coastal areas of Thiruvananthapuram district is hereby relaxed from midnight of 16th August 2020 until further orders.

2. Containment will continue in following wards:

3. All the remaining wards of all the coastal panchayaths will be treated as part of Buffer zone for the purpose of surveillance and containment by Health department and Police.

4. Activities permitted in the Containment zone wards; ie., wards mentioned in para 2 above are :

- i. Fishing is allowed as per the Standard Operating Procedure issued by the District Collector on 15/8/2020 and following Covid 19 protocols like social distancing and compulsory wearing of masks.
- ii. All Government of India and Government of Kerala offices and other public and private establishments are allowed to function on all days with necessary staff (maximum 50%) from 10.00 am to 05.00 pm. All other staff may continue to work from home only.
- iii. Banks and other public/private financial establishments are allowed to function on all days with necessary staff (maximum 50%) in their normal hours of business. They shall issue tokens and introduce queue system to avoid crowding and ensure social distancing.
- iv. All shops are permitted to open from 7 am to 4 pm. Shop owners shall ensure strict adherence to covid 19 prtocols and avoid crowding outside and inside the shops.
- v. Ration shops and Akshaya Centers shall function in their normal timing abiding to Covid 19 protocols.
- vi. The hotels/restaurants can function only with take away counters / parcels. No tea-shops and in-house dining in hotels is permitted
- vii. Maximum number of persons permitted to attend functions like marriage and funerals are limited to 20.

5. The restrictions in the Containment zone wards; ie., wards mentioned in para 2 above are

- i. People are not allowed to move out of containment zone for any purpose other than essential
- ii. health need, maintaining supply of essential goods and services etc
- iii. Entry and exit to and from the coastal wards will be regulated by police. People shall be allowed to enter and exit only for the activities permitted above.
- iv. All congested markets including fish markets shall remain closed. Only Local sale of fish in the respective ward is allowed as per SOP issued separately on 15/8/2020.

- v. All educational institutions including tuition centers shall remain closed. All examinations within the zone stands suspended.
 - vi. All auditoriums, Clubs, Assembly halls, Cinema Halls, gymnasiums, entertainment parks, theaters, swimming pools, barber shops, salons, beauty parlours etc shall remain closed.
 - vii. All social, religious, political, entertainment, academic, sporting functions and large gatherings / congregations are prohibited.
6. Night curfew shall continue to be in force from 9.00 pm to 5.00 am
7. Police shall ensure that there is no crowding in markets and other public spaces and the guidelines issued by Government of India and Government of Kerala regarding the containment zones are complied with in letter and spirit.
8. District Medical Officer shall ensure that Health activities planned as per the ref cited 3 is been implemented. DMO shall furnish a daily progress report to this office by 8.00PM everyday to the email ddmatvpm.rev@kerala.gov.in.
