

PROF. (DR.) K. C. SUNNY AS THE NEW VICE CHANCELLOR

Prof (Dr). K. C. Sunny has been appointed as the Vice-Chancellor of The National University of Advanced Legal Studies (NUALS), Kochi. The order has been signed by the Chancellor, Chief Justice of the High Court of Kerala, Hon'ble Mr. Justice Hrishikesh Roy. At present, he holds various designations such as Dean, School of Legal Studies at the Central University of Kerala & Dean of Legal Studies, University of Kerala.

His academic experience spans over 30 years, including his tenure as Head of Department, Department of Law, University of Kerala, and Department of Law, Central University. Of these, he occupied the post of Professor for 11 years and also served as a Dean for 8 years. After clearing LL.M. with first rank in 1986, he had started his teaching career in Kerala Law Academy Law College, where he had completed his LL.B. and LL.M. Later he joined for research with UGC Fellowship and secured Ph.D.

His publications include the book titled "Corrupt practices in Election Law" and more than 45 research papers. Seventeen students including 2 foreign students, successfully completed Ph.D. under his supervision. He was the international observer to Nepal Constituent Assembly Election, 2006 and Bangladesh Parliament Election, 2007. He has delivered lectures in 16 foreign Universities including Harvard Law School. He served as the Programme Chair of the International Conference on Law and Public Policy held at Singapore, for 7 years.

NATIONAL WORKSHOP ON LEGAL RESEARCH METHODOLOGY & DEVELOPMENT OF RESEARCH SKILLS

NATIONAL LEVEL PANEL DISCUSSION ON THE TOPIC "THE 103RD AMENDMENT ACT: A STEP FORWARD OR A CYNICAL FRAUD ON THE INDIAN CONSTITUTION" ON THE 07TH OF MARCH 2019 AT NUALS.

The political appeasement policies and pressure groups tactics nearing elections the 103rd amendment introduces a new exception—and creates a category allowing reservations for "economically weaker sections of citizens". It allows the government to create a 10% quota in educational institutions and public employment for a new class (the economically weak) in addition to the exceptions made for SC/ST/OBC groups in Articles 15 and 16. And economic weakness is determined by "family income" and other "indicators of economic disadvantage". The fundamental issues with such hasty policy initiatives and constitutional amendments would no doubt strike discords with the intent of the constitutional makers. Objects of constitutional alterations and its proposed nexus with positive changes remain largely questionable in light of desultory political ideologies and partian strategies. The Panel Discussion attempted at a vivid portraying of the issues plaguing the current Indian scenario of reservation in public domain. The Amendment and its impact on the society was minutely analysed for constructive recommendations.

The Panel consisted of eminent speakers like Prof.(Dr.) V.K Ahuja, Delhi University; V.Venkatesan, Senior Associate Editor, Frontline; A.S Paneerselvan, Executive Director of Panos South Asia and the Readers' Editor of The Hindu and Adv.Surya Binoy, High Court of Kerala. After the Panel discussion, an interactive session with enthusiastic interventions from students added to the charm.

The 10% reservation for economically weaker sessions of citizens, a new class was the pivot of the discussions which pointed out that objects of constitutional alterations and its purpose nexus with positive changes remain largely questionable in the light of desultory political ideologies and partisan strategies. The inaugural session on environmental governance



was moderated by Dr. Jacob Joseph, Assistant Professor, NUALS, and started off with a lecture by Prof. (Dr.) Madhav Gadgil, who was the chairman of Western Ghats Ecology Expert Panel (WGEEP), constituted by the Union Government in 2011 study ecology of Western



Ghats. Prof. Gadgil emphasized on the importance of sustainable development, while commending Kerala on having achieved decentralisation and awareness about environment. The second interactive session of the Police-Academia Interaction Forum (PAIF)-Kerala on the theme "Internal Security Challenges in India" was held at NUALS Campus, Kalamassery on April 10, 2019. The interactive session commenced with a panel discussion chaired by Sri. P. K. Hormis Tharakan IPS, Former Chief, Research and Analysis Wing (RAW) and former Director General of Police, Kerala. In his opening remarks Sri. Hormis Tharakan observed that terrorism in all its forms and manifestations



constitutes one of the most serious threats to peace and security. He emphasised on the significance of greater co-ordination between various agencies dealing with terrorism right from the stage of intelligence gathering to intelligence analysis, investigation and prosecution. Mr. Arjun Ambalapatta, Public Prosecutor, one of the panellists, while speaking on the special features of the Unlawful Activities Prevention Act (UAPA) and National Investigation Agency (NIA) Act stressed on the necessity of reforming the sentencing framework under the laws enacted to deal with terrorism. Dr. Jacob Joseph, Assistant Professor, NUALS the second panellist observed that in a federal framework it is important that the Union and states working closely and in unison while dealing with the various challenges relating to internal security. Dr. B. Sandhya IPS, Additional Director General of Police (Training) and Director, Kerala Police Academy in her special address elaborated on the various challenges faced by the state police in the matter of internal security. Prof. (Dr.) K. C. Sunny, Vice-Chancellor, NUALS also spoke. The interactive session involved student presentations on various sub-themes of contemporary relevance. Maria Leslie Fernandes, Ms. Brincy James, Ms. Jemimah Elizabeth Mathew and Ms. Lydia Susan Thomas presented papers on topics such as "Special rules in counter-terror laws", "Freedom of speech and support for terrorism", "Terrorism, Law Enforcement and Privacy" and "Witness Protection in Cases Relating to Terrorism".
