NUALS LEGAL AID CLINIC

Neethidweep is a project being conducted NUALS Legal Aid Clinic in association with the Centre for Continuing Legal Education and Extension (CCLEE) which proposes to study and identify the socio-legal issues of the Lakshadweep Islands. Mendes from Goa who is a well-known figure in the international mediation and arbitration circles, and is also a frequently invited judge to various international moot court competitions; Mr. Uttamkumar Hathi, partner at Brus Chambers Advocates and Solicitors, a top-tier shipping law firm.; Mr. Joy Thattil Itoop, the present Secretary General of the Indian Institute of Maritime Law and the Managing Partner

of Callidus Legal, a specialist law firm in maritime law; and Mr. Gopinath Menon, Senior Advocate at Menon & Pai Associates, Kochi.

The Best Memorial Award was won by Symbiosis Law School, Noida. 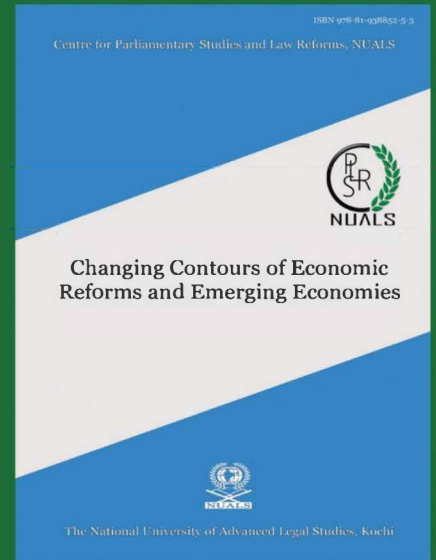
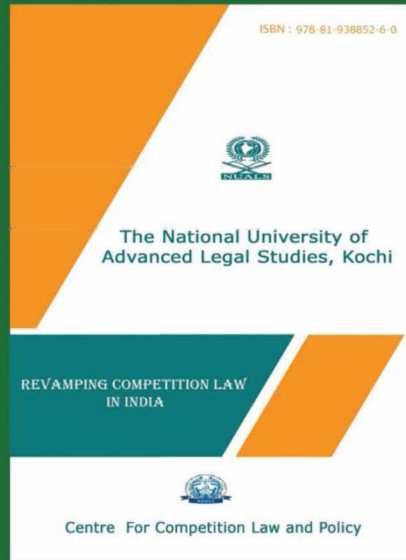
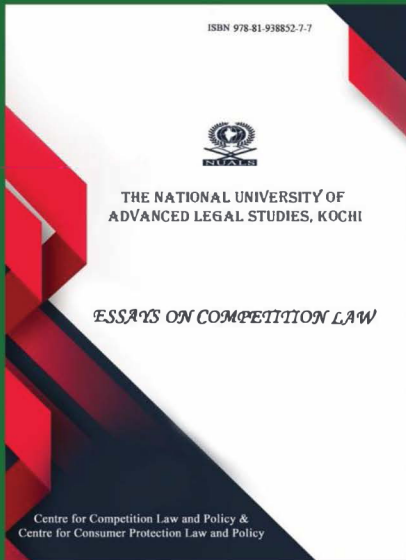
