


# ACADEMIC INTERFACE OF STUDENTS WITH PROFESSOR (Dr.) ROZA PATI

Apart from sharing her experience as a politician as well an academician, she also unfolded opportunities to the students of NUALS to pursue higher education on human rights in her prestigious Institution, Academy of Human Trafficking of which she is the Founder Director.



# STUDY ON IMPACT OF COVID – 19 PANDEMIC



As directed by the University Grants Commission, the National University of Advanced Legal Studies (NUALS) has conducted a study on "Impact of Covis-19 Pandemic on the Socio-Economic Life of Kerala Villages with Special Reference to Strategies Adapted to Combat Challenges Posed". As per the instruction of Vice Chancellor Prof. (Dr.) K. C. Sunny, a research team was formed under the leadership of Pro. S. Mini along with Student Welfare Officer Dr. Sujith Nair and Research Officer Dr. S.Bindu.' The team completed the study in the stipulated time itself and submitted the report to UGC on 30<sup>th</sup> June itself.

The aim of the present study was to find out the awareness, constraints and strategies adopted by the villages

in Kerala to combat Covid 19. By using a questionnaire, the data were collected from 500 respondents from Alangad, Edathala panchayaths and Tripunithura, Trikkakara and Kalamassery Municipalities of Ernakulam District. The study revealed that 47.2% of the people have high level of awareness on Covid 19 pandemic whereas 43 per cent of people have average level of awareness on Covid 19 pandemic and 9.8% per cent of people have awareness on Covid 19 pandemic at low level. In the context of Covid 19 pandemic, more than sixty per cent of people experience discomforts such as fear of illness(64.4%), confusion over the news on social media (61.2%), depression and boredom (60.2)

%) etc. The research revealed that the people in the five areas of Ernakulam district selected for the study have low level of awareness on H1N1 virus or Spanish flue of 1918. Although they are facing many challenges and constraints in their socio-economic life due to this disease, many of the people are adapting different measures to combat this disease. But some of the people are not yet conscious about the rules and guidelines of Government to prevent the spread of this disease.



# SUBHIKSHA KERALAM

'Subhiksha Keralam' scheme aims at large scale production of paddy, fruits, vegetables, tubers, grains and legumes as part of achieving self-sufficiency. As part of the scheme the University has started cultivation of various agricultural crops at the campus. The main crops that are cultivated at the University are tapioca, plantain, yam, elephant foot yam, colocasia and other vegetables. The crops were planted in the 50 cents of land near the Vice-Chancellors quarters.



# ENVIRONMENT DAY OBSERVATION

The World Environment day was observed at NUALS on the 7<sup>th</sup> of June 2020. The Hon'ble Vice-Chancellor of the University Prof. (Dr.) K. C. Sunny inaugurated the programme by planting a bamboo sapling in the Administrative Block of the University. The staff of the University was present during the programme and have planted various saplings throughout the campus. Hundred saplings were procured for the same from the Social Forestry Wing of the Kerala Forests Department.

# Three day training on 'Law Relating to Investigation and Trial in Economic Offences Cases'



The Centre conducted a three day Training programme on 'Law Relating to Investigation and Trial in Economic Offences Cases' for the National Academy of Customs, Indirect Taxes and Narcotics (NACIN), Zonal Campus, Cochin (A Capacity Building Academy, which also conducts Outreach) from 14<sup>th</sup> to 16 <sup>th</sup> January 2020. The Primary beneficiaries of the programme were 30 field Officers of the

Department. The main objective of the programme was to make the participants aware on interpretation of criminal statutes, investigation, collection and presentation of evidences in economic offences.

The different sessions of the training programme were handled by renowned professionals like Hon'ble Justice K.T. Sankaran, Dr. Jacob Joseph, Justice Abraham Mathew, Dr. Balakrishnan K., Mr. L.S. Sathiyamurthy (CBI Judge), Justice Ramkumar K., Mr. Hari S. Nayar & Dr. Vinod Bhattathiripad. Criminal statutes, complaint/First Information Report, exercises and self-assessment on drafting a criminal complaint, evidences and witnesses, types criminal trials, types of evidences, collection and admissibility of evidences, exercises and self-assessment on litigation strategy, filing and case management etc were the topics under discussion of the training programme.

Pilot study of the project was completed by October 2019 where five of our student volunteers visited the island, stayed for four days and did a preliminary survey. The final survey of the project is proposed to be conducted in the month of March, 2020 and is pending approval from the Lakshadweep administration owing to travel restrictions due to Corona virus infection across the globe. There shall be a national level workshop to discuss the issues and problems identified after completion of survey and the final project report would incorporate the recommendations and suggestions that emanate from the Workshop.

# Anti-Human Trafficking Drive


