1. a) Highlight the various recommendations and suggestions mentioned in the various Law Commission Reports and other Committees to make the legislations dealing with socio-economic offences more effective.

b) Critically examine the statement that "legislative measures adopted in India to arrest the menace of socio economic crimes is centered around 'elimination of modification of the requirement of *mens rea*, higher powers to magistrates, search and similar powers, special rules of evidence, *etc*".

2. a) Discuss the evolution of the judicial approach to the interpretation of the term "public servant" in the context of prevention of corruption in the public and government sector. What does the recent judicial approach to these concepts indicate?

b) Compare and contrast the important provisions in the Fugitive Economic Offenders Act, 2018 and the Prevention of Money-Laundering Act, 2002.

3. a) Trace the history and the important provisions in the Essential Commodities Act, 1955. Critically Evaluate the recent amendments to the Act.

Highlighting the important judgments in this Act, give a critical overview of the socio-economic issues associated with this legislation.
